The Promoter - Citroën U.K. Limited, a company registered in England and Wales with company number 191579 whose registered office is at Pinley House, 2 Sunbeam Way, Coventry, CV3 1ND.

How to Participate - To enter this promotion, entrants must fill out the form provided on citroen.co.uk/signlive.html and validly submit their entry.

Only one entry allowed per user

All valid entries received prior to the closing date will be collated into a spreadsheet and the winner will then be picked at random using a random number generator.

This promotion is free to enter, no purchase is necessary.

Entry to the promotion shall constitute your acceptance of these Terms and Conditions and your agreement to be bound by them. These Terms and Conditions apply so far as the law permits so please read them carefully before entering.

Restrictions

This promotion is only open to BSL (British Sign Language) users who will also need to be UK residents (excluding Northern Ireland), aged 21 and over at the date of entry. Proof of age and proof of UK residency may be required.

The prize is intended for use by the winner only.

To operate the prize, the winner will have their driving licence checked, via a DVLA check. A 3rd party company called Licence Bureau will manage the driving licence check on our behalf. Opening and Closing Dates

The Prize

There will be a total of one (1) winner who will receive a New Citroën ë-C4 on loan for a 12-month period, insurance and if required installation of a home charging wall box.

If a home installation is not possible for whatever reason, an alternative Citroën vehicle will be offered as a replacement e.g. New Citroën C4.

If a winner is determined to not be qualify for the insurance provided by the Promoter's chosen insurance provider then the prize is forfeited and the draw will take place again.

The winner for the competition will be chosen by random draw performed by a computer process being a random number generator. The draw will take place on Monday 4th October. All eligible entries will be collated in a data file and a number assigned to each row on which the entry appears, the number picked by the number generator at random will be the winner.

Prizes will be awarded at the discretion of Citroën U.K. The Prize will be delivered to an address in the UK (excluding Northern Ireland). Subject to availability. - (f) not take the Vehicle outside the United Kingdom without the prior written permission of the Promoter;
- (g) immediately report to the Promoter any accident or damage involving or suffered by the Vehicle during the loan period;
- (h) immediately declare to the Promoter any parking fines, penalties, or other motoring offences which are incurred in relation to the Vehicle during the loan period. For the avoidance of doubt, the winner shall be responsible for the payment of any such fines and/or Congestion/Dartford Charges, toll charges which are incurred in the loan period, irrespective of whether they become payable during or after the loan period;
- (i) under no circumstance consume alcoholic beverages or intoxicating substances prior to or whilst driving the Vehicle, nor be under the influence of such substances while driving the Vehicle;

(j) drive the Vehicle only in accordance with applicable law and observing the relevant speed limits and other rules and restrictions, including those set out in the Highway Code; and
