

C5 X Hybrid

C5 X Hybrid combines a PureTech 136 petrol engine (optimised for this powertrain) with a 48V hybrid system to offer a significant improvement in efficiency versus a petrol-only powertrain of similar power.

The Hybrid system enables the car to drive solely on electric propulsion for up to 0.6 miles - while this might not sound much, in urban driving it's possible to experience electric propulsion for up to 50% of the time, reducing emissions considerably around town. In fact, there's a substantial reduction in CO2 emissions whilst driving, typically about 21 g/km versus a PureTech 130 S&S EAT8 (based on the WLTP combined driving cycle).





Performance with care for the environment

With its sophisticated and technologically advanced range of engines, Citroën is well placed to reconcile performance with low taxation levels and reduced environmental impact.

Today more than ever, this means that when choosing a Citroën vehicle you are guaranteed access to superb value for money motoring.

For example, the New Citroën C4 X PLUS, when specified with the Hybrid 136 ë-DCS6 auto powertrain, produces 106 g/km of CO² while driving, and therefore qualifies for the F band of Vehicle Excise Duty.







Company Car Benefit-In-Kind Taxation Charges

The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO₂ emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value[†]).

For example, a New Citroën C4 X PLUS Hybrid 136 ë-DCS6 auto has a CO_2 emissions figure of 106g/km and a P11d figure (as of April 2025) of £24,590.

The BIK value would therefore be $27\% \times \pounds 24,590 = \pounds 6,639.30$.

Graduated Vehicle Excise Duty (Road Fund Licence)

The Graduated V.E.D. bands classify all new cars into one of thirteen Vehicle Excise Duty bands, depending on their type of fuel and carbon dioxide (CO₂) emissions level, measured in grams per kilometre (g/km). There are two V.E.D. rates, a rate for the first year and a rate for subsequent years.

Citroën Personal Lease

Personal Lease is an alternative way to enjoy a new Citroën without the cost of ownership. Instead of owning the car, you rent it for a fixed period and then return it to your local retailer where you can exchange it for a brand new one.

You set your preferred contract terms and anticipated annual mileage. With leasing which can be arranged for a period up to 4 years, Personal Lease offers you an alternative method of funding your new Citroën. One initial bulk advance rental will be required. This is between 14%–16% of the 'On the Road Recommended Retail Price' plus any advance rental contribution from Citroën UK.

Excess mileage charges may apply if the agreed annual mileage is exceeded. Citroën contribution on selected models only. Payment of the optional final rental extends the rental term (this does not transfer title of the vehicle) & requires an annual rental equivalent to one month's rental.
