With its sophisticated and technologically advanced range of engines, Citroën is well placed to reconcile performance with low taxation levels and reduced environmental impact.

Today more than ever, this means that when choosing a Citroën vehicle you are guaranteed access to superb value for money motoring.

For example, the New Citroën C4 X PLUS, when specified with the Hybrid 136 ë-DCS6 auto powertrain, produces 106 g/km of CO₂ while driving, and therefore qualifies for the F band of Vehicle Excise Duty.

Company Car Benefit-In-Kind **Taxation Charges**

The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO₂ emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value†).

For example, a New Citroën C4 X PLUS Hybrid 136 ë-DCS6 auto has a CO2 emissions figure of 106g/km and a P11d figure (as of April 2025) of £24,590.

The BIK value would therefore be 27% x £24,590 = £6,639.30.
