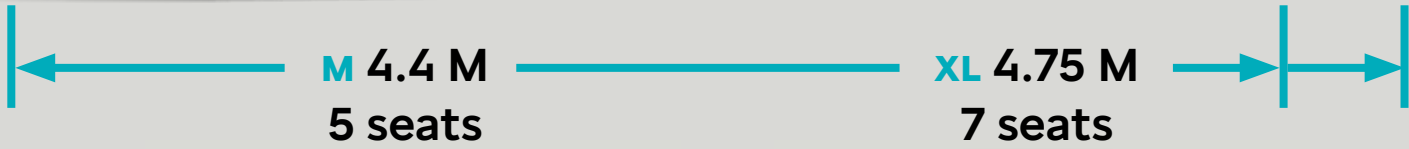



The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO<sub>2</sub> emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value†).

For example a New Citroën C5 Aircross Sense Plus BlueHDi 130 S&S EAT8 has a CO<sub>2</sub> emissions figure of 145g/km and a P11d figure of £30,105.00.

The BIK value would therefore be  
34% x £30,105.00 = £10,235.70.

## Graduated Vehicle Excise Duty (Road Fund Licence)

The Graduated V.E.D. bands classify all new cars into one of thirteen Vehicle Excise Duty bands, depending on their type of fuel and carbon dioxide (CO<sub>2</sub>) emissions level, measured in grams per kilometre (g/km). There are two V.E.D. rates, a rate for the first year and a rate for subsequent years.
